## Field & Clinical Resources

### Preservice Teacher Permit FACTS

Check out the updates facts on obtaining a permit

-Candidates enrolled in non licensure programs but required to be in a PK-12 setting do not need the permit.

-Candidates required to be in a PK-12 setting who already have an issued credential from the SBOE do not need the permit unless required by their own University. Acceptable permits include: educational aide permits, pupil activity permits, substitute teaching licenses, and temporary pupil services licenses

-Candidates completing a clinical experience in PK-12 school settings outside of Ohio are not required to obtain the Ohio Pre-Service Teacher Permit

-According to ORC section [3319.0812 \(B\)](#) a school district or school may employ an individual with this permit as a substitute teacher with compensation.

-Your organization is responsible for monitoring RAPBACK notifications
